#### 5. Business to be Discussed

### 5.1 Plaque Program

The Committee recapped the March 3rd Council discussion regarding the Committee's February 19<sup>th</sup> recommendations. They discussed proceeding with purchasing plaques in phases, with the first year to target the most visible buildings (Town Hall, Stephen Arena and Huron County Playhouse).

Staff advised they would complete the purchase under the Municipal procurement policy, and that they would investigate a process for agreements with landowners regarding the installation of the plaques. Staff advised that for installation of plaques on municipal buildings, Council approval was required.

#### 5.2 Community Improvement Plan Silos

Staff advised that the Community Improvement Plan was still in the drafting stage. Once it is brought back to Council for consideration there would be ample opportunity for public feedback. The Committee would like

to see heritage aspects incorporated into the plan. They advised they were looking forward to seeing the draft and opportunity to provide feedback.

#### 5.3 South Huron Century Farm Program

The Committee mentioned this was brought up at Council recently. This is something to be investigated for commemoration and community engagement. It could generate a lot of interest from the community, celebrating family and property connections.

#### 5.4 Ontario Barn Preservation

The Committee discussed hosting another event similar to last year's, open to the public and would include someone from the Ontario Barn Preservation as the speaker. Member Dinney and Member Neeb will investigate this further.

#### 5.5 Exeter Community Park Gate Pillars

The Committee had concerns regarding the pillars being torn down during the upcoming Victoria Street reconstruction project and inquired about relocating the pillars or salvaging to be repurposed. Staff advised that the plaques and arch would be salvaged, but unsure about the stones. The Committee would like to know what is proposed for the pillars.

#### 6. Correspondence

Staff advised that Council has continued to receive supporting correspondence from Ontario municipalities regarding the Committee's previous draft resolution/correspondence regarding Section 29 (1.2) of the Heritage Act.

## 7. Other Business

Chair Moore mentioned a commemorative initiative in Stratford, where photos of designated properties, along with small write ups are hung in public areas to showcase the municipality's heritage. The Committee discussed and agreed this would be a great way to highlight heritage and provide education. The Committee discussed various locations the photos could be hung throughout the Municipality. Chair Moore and Member Voerman will work on the photos/write ups.
